**Note** – Any trustees not in above will be appointed 'members' plus any other stakeholders proposed at AGM. District Commissioners and District Chair will also be a 'member'

F. Agree the number of members that may be appointed to the Trustee Board.

Note - Minimum 5 and max 12 trustees

G. Agree the quorum for future meetings of the Group Scout Council (excluding this AGM)

Note – At least 10.

## 5. Making appointments

**Note** – The Group Scout Leader/Volunteer is automatically an ex-officio Trustee. Appointed Trustees are appointed by the Scout Council for an initial period of no longer than three years. Appointed and co-opted Trustees must serve no more than nine years over 3 terms. The trustee board can appoint co-opted trustees during the year (but these would need to be appointed by the Council at the next AGM)

- a. Appoint the Group Chair Andrew Horne was appointed last year for up to 3 years
- b. Appoint the Group Treasurer, Jenny Umney was appointed last year for up to 3 years
- c. Appoint members of the Group Trustee Board, Penny Walker and Seymour Poraicu-Vaz were appointed last year for up to 3 years. Lewis Cawte as Group Lead Volunteer is an automatic appointment as Trustee. Additional Trustees can be nominated at the AGM
- d. Appoint Group President and/or Vice PresidentsNo President / vice president to be appointed
- e. Agree Quorum for Trustee Board
  - **Note -** The quorum for a meeting of a Group Trustee Board is one third of the appointed Trustees (ex officio plus appointed plus co-opted) plus one.
- f. Appoint the Scrutineer

The Treasurers recommendation is to retain the existing Scruitineer
